PROCLAMATION NUMBER THREE

Right Excellent Deputy Grand High Priest, Right Excellent Grand King, Right Excellent Grand Scribe, Right Excellent Elected and Excellent Appointed Grand Chapter Officers. Past Most Excellent Grand High Priests, Most Excellent High Priests, Excellent Kings, Excellent Scribes, Past High Priests and Companions of all Constituent Chapters obedient to the Most Excellent Grand Chapter, Holy Royal Arch Masons - Prince Hall Affiliated, Jurisdiction of Pennsylvania,

Greetings:

Holiness to the Lord! Holiness to the Lord! Holiness to the Lord!

As we embark on this continuous journey, I again thank you for re-electing me as your 97th Most Excellent Grand High Priest of all Holy Royal Arch Masons within the Jurisdiction of Pennsylvania. Therefore, by the authority vested in me as the Most Excellent Grand High Priest I, Kevin L. Aleem #6, do hereby direct that this *Proclamation Number Three* be read in its entirety (except for the appendices) in open Chapter and the Executive Orders and Directives contained herein be strictly adhered to and further direct, that this Proclamation shall be available at **every** Chapter meeting and used as a reference.

EXECUTIVE ORDERS

Executive Order No. 1 – Policies and Procedures

The Constitution (latest revision dated October 27, 2002) and The Ritual (latest revision dated 2002) are the governing documents for all functions within this Most Excellent Grand Chapter. If there is an instance where the documented instructions from these documents do not provide the guidance needed for assistance, the Constitution, Landmarks, and By-Laws of the Most Worshipful Grand Lodge should be consulted. If all these documents are unable to provide clarity to the issue of concern, then a written dispensation request must be submitted for review and approval by the **Most Excellent Grand High Priest** *only* before any action can be initiated.

To provide further clarity to Constitutional and Ritualistic issues an appendix has been included with

this proclamation to help keep the Companions updated on approved changes as we prepare for further review, updating and printing of our Constitution and Rituals.

Executive Order No. 2 - Chain of Command

To be consistent with issues identified within Executive Order No. 1 (Policies and Procedures) and to facilitate administrative and operational efficiency throughout the jurisdiction, all matters concerning the Constitution and General Regulations, Laws and Edicts of the Most Excellent Grand Chapter, Holy Royal Arch Masons - P.H.A., the following chain of command is herewith instituted: Any questions, issue or concern beginning with a Companion is first directed to the Most Excellent High Priest of their subordinate Chapter, then to the Excellent Area Deputy Grand High Priest, then to Excellent Deputy-at-Large, then to Right Excellent Deputy Grand High Priest and finally to the Most Excellent Grand High Priest. The official response to the question, issue or concern will be in the reverse order. Thus, informing and/or educating all parties involved. This process will ensure uniformity and consistency within the jurisdiction.

On all issues or concerns regarding the Authorized Ritual for the Capitular Degrees, of the Most Excellent Grand Chapter, Holy Royal Arch Masons, P.H.A., and other related Grand Chapter ceremonies all will follow the enacted chain of command: Any question, issue or concern beginning with a Companion is first directed to the Most Excellent High Priest, then to the Excellent Area Lecturer, then to the Excellent Grand Lecturer, then to the Right Excellent Deputy Grand High Priest and finally to the Most Excellent Grand High Priest. The official response to the question, issue or concern will be in the reverse order. Thus, informing and/or educating all parties involved. This process will insure uniformity and consistency within the jurisdiction.

For all issues that require an immediate response or for situations that the Most Excellent Grand High Priest is unavailable, any member of the Grand Council (Right Excellent Deputy Grand High Priest, Right Excellent Grand King, or the Right Excellent Grand Scribe) may issue a *temporary* response until such time that the Most Excellent Grand High Priest is able to give the final dispensation.

Regarding the chain of command process, responses should be resolved at the first level, provided all parties are satisfied with the findings and/or conclusions. On more complex or difficult unresolved issues, the process should continue until correctly resolved. *Under no circumstance will the Most Excellent Grand Chapter permit the above- mentioned process to be abrogated*

Executive Order No. 3 – Assignments

The Right Excellent Deputy Grand High Priest, Warren S. Montague No. 15 shall act as the Chief Operations Officer for all issues Constitutional or Ritualistic within the Commonwealth. He will train and monitor the committee for the Grand Convocation/Banquet, and work with the Deputy at Large and Grand Lecturer to ensure School of Light (SOL) and Training issues are presented properly. Additionally, he will ensure that all communications radiating from the Most Excellent Grand Chapter are clear, accurate, and timely.

He will serve as the Vice Chairman of the Seminar, Finance, Information Technology (IT), Constitution Codification, Budget, Ways and Means, and Charity Committees. He will oversee the Chairman of the Committee on Foreign Correspondence (CC on FC), Chapter/Charter restoration Project!

<u>The Excellent Grand King Leroy T. Bunyon No. 28</u> shall act as the Vice Chairman of the George Ravenell Toys for Deserving Children Program, Amnesty Day Program, Military Appreciation Day, 204th Birthday Celebration Programs, and special projects. He will develop sustainability/longevity protocols to be taught at Seminars or any training opportunity.

He will serve as a member of the Seminar, Finance, Information Technology (IT), Ways and Means, Charity, Finance, Ritual/Constitution Codification and By-Laws committees.

Both he and *The Right Excellent Grand Scribe Agoi Ombima*, No. 53 will work on the Chapter/Charter restoration Project!

<u>The Right Excellent Grand Scribe Agoi Ombima</u>, No. 53 shall act as Vice Chairman for By-Laws submission and review/updates, and Good Guys Charity committees. He will serve as a member of the George Ravenell Toys for Deserving Children, Amnesty Day Program, Ways and Means, and 204th Birthday Celebration Programs, Finance, Information Technology (IT), and Charity committees.

Both he and *The Right Excellent Grand King Leroy Bunyon*, No. 28, will work on the Chapter/Charter restoration Project!

<u>The Excellent Grand Lecturer</u> will be responsible for all instructions pertaining to the authorized ritual of the Most Excellent Grand Chapter. He will supervise all Area Lecturers and will ascertain that none, but the authorized ritual of the Most Excellent Grand Chapter is used. He will oversee and ensure competent degree teams, and teams to support our public and private Ritualistic Ceremonies (i.e.: Annual Memorial Service, Zerubbabel Festive Day, Opening of Grand Convocation, etc....) Ensure and organize proper enlightening lectures and subjects are presented, discussed, and illustrated at Area and Statewide Schools of Instruction.

He will serve on the committee for the Chapter/Charter restoration Project!

<u>The Excellent Deputy At Large</u> will ensure that all Excellent Area Deputy Grand High Priests work with each Chapter to ensure they are following the requirements of the Constitution of the Most Excellent Grand Chapter and responding to the requirements of all Proclamations. He will serve on the committee for the Chapter/Charter restoration Project!

They (EADGHP) will ensure all dispensations are submitted timely, <u>sixty (60)</u> days prior to the date of the activity (degree work, church service, out of State visitation, change of meeting, social activity, etc...) and will approve/decline dispensations timely (within 20 days of receipt). They will ensure dates for social functions, tickets, programs and souvenir journals are to be approved **prior to and after printing**. They will ensure that when inviting the Most Excellent Grand High Priest and/or the Most Worshipful Grand Master proper protocol is adhered to. They will ensure the submission of taxes in accordance with established timelines.

Executive Order No. 4 – Fiscal Responsibility

- 1) It is each Chapters responsibility to update their status reports as needed and **no less than each quarter!** The office of the Right Excellent Grand Statistician or the office or the Right Excellent Grand Assistant Secretary will issue a Quarterly Status Report and the Accounts Receivable Billing Report.
 - a) The Quarterly Status Report will be completed by the Chapter's Secretary, given to the Most Excellent High Priest for approval and then returned to the office of the Right Excellent Grand Statistician or the office of the Right Excellent Grand Assistant Secretary.
 - b) Full payment of all amounts due are to be returned to the Right Excellent Grand Secretary on or before the 15th of the quarter owed.
 - c) Any Chapter that is more than **one quarter delinquent** with their fiscal responsibilities will be reported to the Most Excellent Grand High Priest for additional follow-up!
 - d) Any Chapter or individual who submits a check to the office of the Right Excellent Grand Secretary and said check must be returned to the sender for any non-payment reason; he or the Chapter will be required to pay the amount of the check and any additional fees that are incurred. You shall also be required to submit all future transactions in one of following methods: (1) Certified Check, (2) Bank Money Order or (3) U.S. Postal Money Order.
- 2) It is hereby ordered that the fiscal officers (Secretary & Treasurer) of each Chapter be bonded for no less than \$10,000 each. This is to protect the financial stability of each Chapter. This order must be complied with by 1/31/2024!
- 3) No audit of a Chapters fiscal records may be completed by a member of that Chapter or a

person unqualified to complete the required task! This is to avoid conflict of interest and ensure integrity with each Chapters fiscal status. As of 2/15/2024, the Grand Chapter will have a list of qualified auditors available with a standard fee for all. This list will be available from the Right Excellent Grand Assistant Secretary- assistantsecretary@megcofpa.com

This order will be strictly enforced!

Executive Order No. 5 – By-laws review/updates

This area is being continued due to a lack of full participation during the prior year! All Chapters *must* submit a copy of their most recent By-Laws to the Right Excellent Grand Scribe no later than 12/31/2023. This includes a Draft from the two newly formed Chapters #4 & #44. The Chapters By-Laws will are being reviewed due to the need for updates identified during the prior year. The By-Laws will be reviewed and returned with notes for Constitutional and/or functional updates. It is the Chapters responsibility to present the updates/recommendations to the Companions and then prepare them for submission to the Jurisprudence Committee by 6/30/2024. This will allow for further review and consideration of approval at the next Convocation. It is the Chapters duty to make constitutional corrections and the Companions fully control whether any of the recommendations are needed for your Chapter.

It is strongly recommended each Chapter include within their by-laws a Children's Charity Chairman who possesses a clear state child abuse certificate (CY113). To support this initiative your Grand Chapter will pay for one Companion in at each Chapter to receive this certificate if none has it.

Executive Order No. 6 - Benevolent Affairs Report

All Chapters **must** submit a Report no less than each quarter of their Companions who have experienced an illness which has lasted approximately 90 days or is serious in nature. Also, your status report should include and highlight all Companions in the Chapter who are over 65 years of age. This should be sent to both the Right Excellent Grand Assistant Secretary-assistantsecretary@megcofpa.com and Right Excellent Grand Statistician-regstat@megcofpa.com
This information will be given to the Excellent Chairman of Benevolent Affairs who will review the report and contact the Companion or send Masonic greetings from the Most Excellent Grand Chapter. Also, all Companions who have been Holy Royal Arch Masons, 25 years or more are to be included with this report.

Additionally, this Order expressly forbids the administrative removal of any Companion experiencing Alzheimer's, Dementia, or diagnosed with severely diminished mental capacity (including Traumatic Brain Injury) from a Chapter's rolls! The following are guidelines to support the Chapter and Companion:

- 1) The Companion must have been a member within Holy Royal Arch Masonry for over 15 years (This may be broken or unbroken service)
- 2) The condition must be verified via a physician's documentation and/or by visitations documented within the minutes of verification/affirmation from no less than 5 Companions, two of which must be of the Council and/or Past High Priest
- 3) The Chapter must move, second and vote that the Companions' condition makes him eligible for dues/tax exemption.
- 4) The Chapter must submit a request (dispensation) to the Most Excellent Grand Chapter for final disposition. This should be through your Area Deputy Grand High Priest
- 5) Once reviewed, if all criteria have been met, the Most Excellent Grand Chapter will approve the dues/tax exemption. This part of the process will be less than 10 days.

Once this process is completed, the Chapter will no longer collect or pay any dues/tax from this Companion. The Companion will be listed as exempt and remain eligible for all rights including funerals and Burial fund payment. His service year count will cease, and he will be recognized by the highest status obtained while in service to his Chapter and the Most Excellent Grand Chapter.

This Order provides for Companions that have <u>permanent</u>, severely diminished mental capacity, <u>only!</u>

Past Most Excellent High Priests and Most Excellent High Priests *are* members of the Holy Order of High Priesthood and as members they are encouraged to attend the Priesthood meetings. These meetings are held quarterly starting with the anointment each year. The Priesthood also sponsors an annual Banquet honoring "Those Who Have Served," and provides stipends to support young individuals with continuing educational efforts.

To establish consistency with budgeting and operations, the dues, for the Holy Order of High Priesthood of \$5 (per annum), will be collected from each Past Most Excellent High Priests and Most Excellent High Priest at each Chapter during the month of January. These funds will then be turned over to the Right Excellent Grand Secretary no later than February 3rd, 2024 and then forwarded to the Holy Order of High Priesthood by February 15th, 2024.

Executive Order No. 8 – Festive Days, Black Out Dates, Closures, Holy Week

It is hereby ordered that under no circumstance will any Chapter, Triangle Club or Unit obedient to the Most Excellent Grand Chapter, Holy Royal Arch Masons - P.H.A., Jurisdiction of Pennsylvania sponsor, convene or participate in **any** event on the date when a Grand Body of the Prince Hall Family observes their Festive Day, Memorial Service, Annual Session. Or National Holiday (including holidays that are observed on non-standard days due to the holiday falling on a weekend) It is the Chapters responsibility to ensure that conflicts with blackout dates is avoided or that a special request dispensation is provided that avoids/minimizes any conflicts.

Also, under no circumstance will any Chapter, Triangle Club, Unit, adopted or affiliated body obedient to the Most Excellent Grand Chapter, Holy Royal Arch Masons - P.H.A., Jurisdiction of Pennsylvania sponsor, convene or participate in non-religious social events during the observance of Holy Week, commencing at 12:01 A.M. Palm Sunday, March 24, 2024, through midnight Easter Sunday, March 31, 2024. Additionally, the following are considered "Black Out" dates by the Most Worshipful Grand Lodge, and we will follow the same requirements as Festive Days:

- A) Most Worshipful Prince Hall Grand Lodge- Christmas Celebration December 2nd, 2023 (Youth and Adult)
- B) 4/6/2024
- C) Most Worshipful Prince Hall Grand Lodge- Mid-Year Session in Gettysburg, PA April 11-12, 2024

For a full list of Sessions/Convocations/Memorial Services for 2023 – 2024 see attached appendix #2 Furthermore, whenever inclement weather causes the local school district to close, all Chapters within that area are to be closed to support the health and welfare of our Companions.

Executive Order No. 9 — George Ravenell's Toys for Deserving Children Program

Each Chapter should be an active participate in the George Ravenell Toys for Deserving Children Program! Each year during the Christmas holidays, your Most Excellent Grand Chapter provides toys to disadvantaged children. This program is a show of our charity and, many times, may be the only holiday celebratory action some of our children have. We request all Chapters give one male and one female toy or donate twenty dollars (\$20.00) to the program **each month**. Your Area Deputy Grand High Priest will follow up with your Chapter and assist with collection arrangements so that we can continue to provide toys in the various communities throughout the state.

Executive Order No. 10 - Triple Tau Magazine

The Triple Tau Magazine will be converting to and an electronic format so we can email the magazine in a timely manner. We will continue to mail copies to Companions who do not have electronic access (email) and those who prefer standard mail, To ensure proper receipt each Chapter must update their databases to ensure the Triple Tau Magazine is received. This includes accurate and

updated email addresses! As always, if a mailed Triple Tau Magazine is returned for an incorrect address or zip code, the Chapter will pay for that return.

Note: Each Chapter should have a reporter to submit news items, articles and photographs to the Triple Tau Magazine every month.

Executive Order No. 11 – Enhanced Communication - Website/Email updates

This website is in its toddler stage, but you will see the numerous opportunities it offers as we continue with our needed upgrades!

Please note if you go to megcofpa.org or megcofpa.wix you will be directed to our old shutdown website! It will take some time for it to be completely deleted.

As you visit the new website, brows and make suggestions to your Grand Council, that may improve our organization and how we present Pennsylvania Holy Royal Arch Masons to the world!

To further support all Chapters, and to enhance communication, **email addresses have been provided for all the Chapters and executive officers**. This will provide us with a consistent method of communication now and into the future. Access and instructions for usage of your Chapters email account has been provided to your Most Excellent High Priest and Secretary If password difficulties arise you are to contact Right Excellent Assistant Grand Secretary Walt Samuel-assitantsecretary@megcofpa.com for assistance. A full list of all new email accounts has been added to the attached as appendix #3.

Please Note - Your Most Excellent Grand High Priest or one of the Council will be sending a monthly message (GHPM will be in the subject line) for all companions through our Chapter email service. This message is to be read at the next Chapter meeting the following month! The message will be short and will be sent on the 30th of each month, starting 10/31/2023. (Check your email because one is waiting for you now!)

DIRECTIVES

Directive No. 1 - Health and Safety

To protect the health and safety and of all companions, as we continue to recover from the Pandemic, we will be implementing safety protocols. These protocols will not place an enhanced burden on any Chapter and will aid with the maturation of our Companions and support efforts to have more Companions attend our communications.

Please enact the following:

- 1) All Chapters are to have disposable gloves and disposable mask available for all Companions who wish to use them at any meeting. This is vital since two parts of our ritualist opening require close contact.
- 2) All Chapters are to obtain supportive kneeling pads to assist with the physical demands of our ritualistic openings, closings, and degree work. Supplies of mask, gloves and kneeling pads will be available for purchase at the Grand Chapter 4301 N. Broad Street.

Directive No. 2 - Lectures and Masonic Information

All Most Excellent High Priests are directed to have a lecture or Masonic information pertaining to

Holy Royal Arch Masonry given at every meeting. For the months of March 20244 and May 2024, the Grand Chapter will provide the required Lecture

Directive No. 3 - Degree Work and Use of Ritual

All constituent Chapters are directed to notify the Excellent Area Lecturers of their rehearsals for degree work, including dates, places and times. **Under no circumstance will rituals be used during the opening/closing ceremonies, funeral ceremony and the conferring of degrees!**

Should a Council or Chapter be unable to perform ritualist degree work, They are to work with their Area Lecturer for additional support. If standard methods of support are not available to complete degree work in a timely manner, a Chapter may request the usage of the Grand Chapter Degree Team! This is *not* a free service and **should only** be used when all other avenues are exhausted! *This cost cannot be used to increase joining fees or passed on to new Companions!* This will ensure that new members are initiated in the correct ritualist manner. Funeral teams will not incur a charge!

All Companions must show reasonable proficiency with a degree before being presented with the next sequential degree!

Note Petitions must be acted upon (Degree work started) within 120 of the Chapter receiving the petition!

The cost for the use of the Grand Chapter Degree Team is as follows:

4th- Mark Master Degree - \$250

5th - Past Master Degree - \$150

6th – Most Excellent Master Degree -\$250

7th – Holy Royal Arch Degree \$350

Directive No. 4 – School of Light/Instruction

Due to scheduling conflicts, and numerous other situations that affect their ability to meet, we will be looking at the continuation of Area Councils during this Capitular year. In the meantime, there will be a minimum of 4 Statewide Schools of Instruction. Further actions will be discussed at the Seminar in January 2024

The statewide Schools of Light/Instruction will be held during the following months (February, June, September & October)! These will be held using Zoom and a link will be sent for these meetings. It is the intent of this Grand Council to ensure all the companions are receiving and opportunity for direct communication with your Grand Council and ensure Ritualistic and Constitutional Information is consistent throughout the Commonwealth.

Chapter representation is mandatory, and All Most Excellent High Priests, Excellent Kings, Excellent Scribes and Captain of the Hosts are expected to attend the Schools of Instruction unless excused by their Area Deputy Grand High Priest! Most Excellent High Priests should encourage all of their members to attend and participate with the Schools of Light/Instruction Schools of Instruction

All Right Excellent Elected and Excellent Appointed Grand Chapter Officers are expected to attend the Schools of Instruction unless excused by the Right Excellent Deputy Grand High Priest, Warren Montegue #15. An attendance record will be kept and reviewed for compliance.

Directive No. 5 - Deceased Companions

When a death occurs within a Chapter you are directed to employ the following procedure: Upon receiving notice that a Companion has passed, the Most Excellent High Priest, with his cabinet will consult with the Companions Lodge (Worshipful Master) and if appropriate, visit the family and secure the following information:

- 1. Whether or not the family wants the Holy Royal Arch Funeral Service performed?
- 2. Date, Time and Place of the funeral.
- 3. If necessary, consult with the Minister or Funeral Director and WM of his lodge to coordinate arrangements.
- 4. Obtain a copy of the Death Certificate, to complete any benefit processing that may be due

Inform the Excellent Area Lecturer and Excellent Area Deputy Grand High Priest via telephone of these facts and complete the "Report of a Funeral." Once completed, copies of the document are to be given to the Excellent Area Lecturer and the Excellent Area Deputy Grand High Priest.

Should the death occur within the active ranks of the Most Excellent Grand Chapter, the Most Excellent High Priest will **immediately** notify the Most Excellent Grand High Priest and the Right Excellent Grand Secretary.

Directive No. 6 - Dates to Remember January

Grand Chapter Seminar, **Saturday January 6th**, **2024** 9am- 2:30pm (inclement weather date 1/13/2024), at the Scottish Rite Cathedral, 2701 N 3rd Street, Harrisburg Pa., 17110 (Lunch will be provided) Business Casual Dress. <u>Councils and Fiscal officers are expected to attend!</u>

Release of application for Camp Sankanac charitable efforts, February 29th, 2024! Closing date April 30th, 2024

March

Amnesty Month- The month of **March** will be a month for all Companions that have been dropped from our roles to visit a Chapter and be encouraged to return to active status! The lecture for that day will be provided to all Chapters.

Additional instructions:

The Right Excellent Grand Statistician has prepared information on Companions dropped from the rolls, of each Chapter, for the last 12 years (2012). This information will be transmitted to the Chapters via the new email system. Your ADGHP will also be provided with this information. Once received, the Chapter is to attempt to contact the members listed and invite them to **your or any Chapter's meeting** within the month of March. This invitation has no requirements other than to provide an opportunity to fellowship and experience Capitular Masonry with their fellow Companions (aprons, gloves and a head covering *hat* is acceptable for this meeting). The Grand Chapter will provide the Lecture of the month.

Should a Companion desire to be reinstated, the following fee schedule and requirements are to be followed:

- 1) A reinstatement fee of \$175 must be paid as follows
 - a) \$125 on or before 4/30/2024 (\$75 to the Grand chapter for 2 years of dues (2023-2024 & 2024-2025) and administrative fees \$50 is retained for the Chapter)
 - b) \$50 on or before 9/30/2024 (all retained by the Chapter)
 - c) No further dues will be required from the returning Companion until 10/2025
- 2) The returning Companion must complete a reinstatement form. This form will be used to identify if the Companion feels he was unjustly dropped or to provide suggestions for retention and support of Capitular Masonry. The form will also identify if a Companion is returning to their original Chapter or a different Chapter. These forms submitted directly to the ADGHP/DAL. Upon review by the Grand Council, a determination will be made on the improper/unjust dropping request. If it is approved the Companions years of service will be fully restored. This will be noted on the certificates of restoration received in September 2024.
- 3) Returning Companions are fully re-instated upon payment of the first \$125. All returning Companions will receive their certificates of restoration after the second payment (\$50) is received in September 2024.

MEHP – COH inform the outer Guard that we are going into Devotions and Closing COH – (Performs that duty) Reports to MEHP that the Outer Guard has been informed

MEHP –(3 raps of the gavel) PS you and 2 Companions will form a triangle at the alter and lead us in devotions (**Devotions are conducted with the MEHP having the last devotion**)

MEHP – PS and Companions, return to your station

MEHP - Look to the Council and as I do, you do likewise (The MEHP will then display the signs in descending order from the 7^{th} degree to the 4^{th} degree)

MEHP – Gives the closing prayer (Page 52). Instructs the PS to close the great lights and COH to inform the Outer Guard that we are closed (COH reports that the outer Guard has been informed)

MEHP - (1 rap of the gavel) Good Evening
